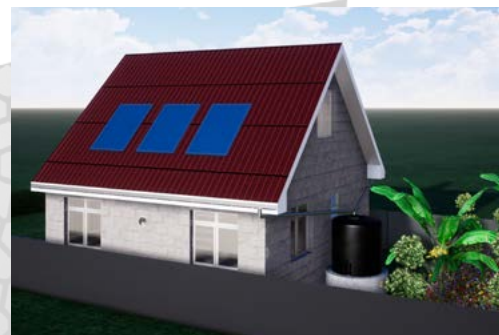

# What is CHT's fundraising target and how is it going to be met?



The total Korogocho project cost is estimated at £350,000 (Ksh 45m/-)

The efforts of the CHG team and MWAMKO members themselves may bring down the final cost a little. In the event of CHT having a fundraising surplus at the completion of the Project this will be allocated to the charity's next project, ensuring the continuation of Clifford Dann's legacy. Donors will be kept informed of everything which their generosity is making possible.

It is anticipated that this will be raised through coordinated initiatives between CHG operating in Kenya and Commonwealth Housing Trust operating in the UK.
